Contract for Internal Broadband Management

TERMS

This is a contract between RS Services, LLC (RSS) and White Pine Charter School (WPCS) for providing management services for internal connections at White Pine Charter School. This service includes management, monitoring, troubleshooting, upgrading and configuration of all internal broadband connections. This covers the following: existing facility cabling plant, switches, routers, web and Internet filters, firewalls, ET AL.

The contract shall be in force from July 1st, 2023 until June 30th, 2026. If either party wishes to end the contract earlier, 30 days' notice from the initiating party is required.

Payments will be made once a month for \$1500.00 USD. To RS Services, LLC.

Access. WPCS will provide RSS access to the building and to all rooms that contain information technology equipment. This includes server rooms, classrooms, admin offices, computer labs, kitchen area, outside utility closets etc. This access must work 24 hours per day, 365 days per year.

Exception clause. RSS hires and employs professionals who actively hold full-time jobs in other school districts. While this gives many and marked advantages to WPCS, it does mean that response time to requests will vary. Immediate availability of an RSS tech will not be the same every time.
