- Office Referral—Principal Conference w/Student
- Verbal Correction/Student Behavior Log
- Apology/Restitution
- In-School Suspension (1 - 2 days) and/or Suspension of Privileges (2 weeks)
- Behavior Modification Program (during ISS and Suspension of Privileges)
- Adult Mentoring Program
- Principal Referral to School Counselor
- RTI Committee & Teacher Conference—student observation
- Parent Conference w/Principal

**3<sup>rd</sup> Offense**

- Office Referral—Principal Conference w/Student
- Verbal Correction/Student Behavior Log
- Apology/Restitution
- In-School Suspension (2-3 days) and/or Suspension of Privileges (3 weeks)
- Behavior Modification Program (during ISS and Suspension of Privileges)
- Adult Mentoring Program
- Principal Referral to School Counselor
- Parent Conference w/Principal
